#### Do we use "cookies"?

Yes, but only with your knowledge and consent. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser and capture and remember certain information. We use them for our affiliate program (WP Affiliates): http://www.jodichapman.com/affiliates. IPs are tracked up to three months so if an order is placed, the person who referred them will receive a commission. Our website uses several types of third-party cookies, and we do not control the operation of them: social sharing plugins are used when you share a link, and Askimet blocks spam comments.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser (like Internet Explorer) settings. Each browser is a little different, so look at your browser's Help menu to learn the correct way to modify your cookies.

If you disable cookies, it won't affect the user's experience and you can still place orders.

We use a third-party provider, MailChimp, to deliver our newsletter, blogs, and other email updates. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our services.
